**OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST.**

1. **CONTEST PERIOD:** The Unleash Your Inner Explorer Contest (the “**Contest**”) starts at 12:00 AM Eastern Time (“**ET**”) on September 18, 2021 and ends at 11:59 PM ET on October 31, 2021 (the “**Contest Period**”).
2. **ELIGIBILITY:** Contest is open to legal residents of the fifty (50) United States & the District of Columbia (excluding Mississippi, North Dakota, West Virginia & Wyoming) who are twenty-one (21) years of age or older as of date of entry. Evaton Inc. (the “**Sponsor**”), and its subsidiaries, affiliates, employees, directors, and advertising, promotional and judging agencies, including Don Jagoda Associates, Inc.
